Consistory Highlights

Pastor's Report: The Norland's will be welcoming a Rotary student from Thailand to their home soon. Pastor Peter said he is excited about the work he is doing with Pastor Sarah from Good Shepherd Lutheran Church for Lent. Those attending the weekly soup and bread and worship service will be exploring the "Fruits of the Spirit" together. Ann Campbell assisted with communion in February and will assist again in March.

Office Manager: Three more requests for Helping Hands assistance have been received since the Office Manager report was written three days before the meeting. This brings the total number of requests to 14 for the first 1 ½ months of 2024.

Angel Mission: Elder S. Middlemis-Brown reported that Angel Mission assisted 200 people with food in January (a shorter month as the Mission was closed for the holidays). Also 316 volunteer hours were recorded in January. Angel Mission received \$39,000 from Giving Tuesday. They also received \$2,500.00 from the Portage Health Auxiliary to be

used toward winter outerwear. The 2nd Annual Open Meeting will be held on Tuesday, February 20, 2024.

Old Business

Clerk of Session and Denomination
Representatives: A description of the
Clerk of Session duties provided by retiring
Clerk Terry Monson was passed out. Office
Manager Smock will put information about
this position in the Weekly email and March
newsletter as we look for someone to step
forward for this important leadership
position. The Middlemis-Browns will be
serving as the Presbytery denominational
representatives. We are still looking for
someone to serve as the UCC representative.

Congregational Meeting: People liked the budget charts developed by Elder R. Middlemis-Brown and found them helpful in understanding the budget.

Leave Policy: The Leave Policy was refined and will be approved at the next Consistory meeting.

Building and Grounds: Building and Grounds would like to know how long each

group has been using our building and when was the last time they were approved.

New Business:

Special Music: Consistory approved using vonBatchelder funds to pay for special music. \$240.00 was approved for 2023 with \$300.00 approved for 2024 (musicians for 5 Sundays at \$60.00 each).

Congregation/Corporation Spring Meeting Highlights

Pastor's Report: Pastor Peter expressed his gratitude to the congregation for their support and prayers over the last year. He also thanked Susie Byykkonen for the music she provides each week plus those who have provided special music, Office Manager Beth Smock for keeping the office running, and Fellowship Guild ("the heart of the congregation") for all that they did over 2023, plus the members of Consistory for their work. Pastor Peter spoke about some of the things that make PLUC a unique congregation including our welcoming of all people, our taking the Bible seriously if not always literally, and our heart for justice steeped in the teachings of Jesus. Pastor Peter will be spending the next 12 months working with the congregation to encourage our growth as individuals and as a church.

Denominational Representatives: Pastor Peter shared information about the role of our Denominational Representatives and asked that anyone who might be interested in filling these positions speak to Pastor Peter or a member of Consistory.

Election of Elders: The Nominating Committee chair Barb Brookhouse informed the congregation that the committee nominates Terry Monson and Al Eckhart as the Consistory class of 2026. There were no other nominations from the Congregation. The Elder class of 2026 was approved.

Election of Financial Officers: The Nominating Committee put forward Edward Lowther as the Church Treasurer and Beth Smock as the Financial Secretary. There were no other nominations from the Congregation. Both were approved.

Pastor Terms of Call: The congregation approved the Terms of Call for Pastor Peter Norland.

2024 Budget: Rob Middlemis-Brown, Member of the Finance Committee, discussed the PLUC Budget presented for 2024. He presented a short slide presentation showing where our incomes from and where the monies are spent. Included in this presentation was a comparison between the income/expenses in 2023 and those expected in 2024. Due to the fact that pledges were down slightly for 2024 and expenses were slightly increased, PLUC will be operating with a deficit budget for 2024. He did inform the congregation that a Capital Improvement fund has been started using the monies received from the easement payment as the original investment in this fund. The 2024 budget was approved.

Dianne Sprague to recommend that the Budget and Building and Grounds Committees work together to get an estimate on the worth of the PLUC infrastructure (building, property, etc.)

2023 Annual Report: The 2023 Annual Report was approved

Adjournment: Dianne Sprague moved (Barb Brookhouse second) to adjourn the Meeting of the Congregation. Approved.

The Corporation Meeting Convened Following the Meeting of the Congregation

Open the Meeting: Clerk Pro Tem Ann Campbell opened the meeting of the PLUC Corporation

Approve the business of the Congregation meeting: The business of the Congregation Meeting was approved.

Adjourn: The meeting was adjourned with Pastor Peter closing with prayer.

The Meaning of Lent

Lent is the forty day period (we don't count Sundays—every Sunday is a little Easter!) beginning with Ash Wednesday and ending with the Saturday before Easter Sunday. Long ago, Pope Gregory I described Lent as "the spiritual tithing of the year." This is a season in which we remember Christ's forty day fast, temptation in the desert, and the forty hours he spent in the tomb before rising Easter morning.

In the preceding liturgical season, from Epiphany to Transfiguration, we were invited to contemplate the identity of Jesus as the Christ and our call to follow. The focus of Lent is on the way in which Jesus chooses to embody this identity as Christ in the world, and so we also consider the shape of our lives as we seek to embody Christ's ways. In short, Lent is about spiritual renewal in the pattern of Christ. When we incorporate aspects of the traditional Lenten practices of prayer, fasting and almsgiving, we cultivate our attentiveness to the work of God's Spirit in our lives. Such practices change us by changing our daily routines: the addition of prayer and giving or the subtraction of fasting provide real, embodied opportunities to (re)turn to God and recenter our lives in the way of Christ.

Each Lent we get a clean start to seek the Spirit and to change our minds and our ways. From the reminder of our frailty and mortality at the outset on Ash Wednesday, throughout the 40 days, we renew our hope and place our trust in the God to whom Jesus points. And we will not be disappointed, for when the forty days come to an end, we will once again sing *Alleluia!* to the God of overflowing grace who raised Jesus from the dead and promises to incorporate us in glorious resurrection life.

Some of the individuals who pride themselves in supporting PLUC and various needs such as social, financial and organizational activities, gathered last month. Eleven of us were able to meet face to face and address these areas on Monday, February 12th in the limited space, private dining room at The Bluffs.

We initially gathered at 11:30 to fill 8 Valentine bags with miscellaneous items for our members and friends we don't see on a regular basis. Unlike the holiday baskets they received in December, these were composed of personal items as well as snacks and sweets. Four residents joined us or stopped by. We enjoyed brief conversations, hugs and handshakes.

Topics such as updating forty year old bylaws and the Easter breakfast were also discussed. Since our treasurer was not in attendance, we will vote on the budget and by-laws update at a later time. We had a preliminary meeting to review the by-laws in late February and the Easter breakfast is scheduled for 9:30 on Sunday, March 31st. More information will follow.

As Valentine's Day was just two days away, timely readings were shared by Lois Jambekar and Judy Albee. Although The Bluffs' residents took 'mid-winter cheer' bags with them, Biruta Lowther and Judy Albee delivered the remaining four to the facilities or homes of the others.

Although dates have yet to be announced for future events/projects, we anticipate doing some cleaning and refurbishing at PLUC this spring. 'Many hands make light work/and play'. We also look forward to gathering on the outside patio at The Bluffs, weather permitting, when more of our members and friends can attend.

Clerk of Session and Wisconsin UCC Representative

We currently have two important volunteer positions to fill. We have mentioned these in the past but have not really explained what they do. Below is more information for those who might have an interest in either of these positions.

Clerk of Session

- 1. Presides over the corporation meeting when the congregation meets in November and February,
- 2. Completes PCUSA and UCC statistical surveys in January or February.
- 3. Travels to Marquette usually once a year for a Presbytery review of church records (minutes of church meetings and updates to the church registry).
- 4. Prepares the paperwork that gives Peter the Terms of Call that are then sent to the Presbytery.

5. Periodically prepares the Clerk's Report for Consistory meetings.

Wisconsin UCC Representative

The Wisconsin UCC meets at least twice a year to discuss important information from the Conference. The PLUC representative can either travel down to Wisconsin (meeting locations differ each meeting time) or attend over ZOOM. Our representative will share what is happening at PLUC and bring back to us information from other churches.

We thank Terry Monson who has served as the PLUC Clerk of Session for several years. While he has stepped back from that role, he will remain active as he begins a three year term as an elder in June.

We also thank Sherry and Rob Middlemis-Brown who have accepted the position of Presbytery Representative for 2024. They have recently attended the Presbytery meeting in February and their report is below. This gives an idea for what kind of information is shared during these meetings.

Key Points from the February 24, 2024 Presbytery Meeting

Sixty-two commissioners, pastors, and presbytery officials participated in the meeting via Zoom. Several interesting items were discussed, including the budget, a grant to train lay pastors/CREs, a mission opportunity, committee vacancies, and Presbyterian Point Camp.

 Matt Aragon of the Synod of the Covenant spoke about a large grant received to assist with training lay preachers. Nominations for

- applicants should be sent by April 5. The Presbytery should be able to guide those applicants to the proper office. The training will be at a conference in Alma, June 6-10. Cost is \$250 for the individual and \$1000 for the sponsoring church with the grant covering the rest of the cost.
- The mission budget is being balanced for 2024, as opposed to the deficit in 2023. Campus ministries in Bay De Noc and Northern were reduced, but they had not used all of their 2023 budget. Copper Country Angel Mission received its full amount, as did Presbyterian Point.
- The Missions Committee and Presbytery has begun the 366 Campaign to return mission spending to its previous levels. Also called, "The 2024 Leap Year Challenge" it asks that each parishioner give \$1 per day or \$366 to Presbytery directly for covering Presbytery mission. Our church does not make significant contributions to Presbytery mission, but our local mission benefits greatly from the Presbytery's spending. You can write your check to Presbytery of Mackinac, memo line: 2024 Leap Year Challenge and submit it through the church. All of it will go to mission.
- There are vacancies on Presbytery Standing Committees. If you are interested in serving or know someone with a talent to share, the Presbytery invites you to step up.

Rev. Jim Porter announced that camp registration is open for Presbyterian Point (see presbyterianpoint.org). They are also looking for staff and volunteers, volunteers being welcome for as little as a few days. Family Camp, intergenerational camp, is June 14-18 and costs \$50/person. First Presbyterian Grand Haven offers camp scholarships from a donor who offers youth scholarships to attend faith formation camps. Contact Presbyterian Point or check online. No camper will be excluded because of financial need.

Copper Country Angel Mission

On Tuesday evening, February 20, CCAM held its corporate annual meeting. We reported on how things went in 2023 and on our hope for 2024. We invited many of our stakeholders, various organizations, businesses, and individuals. The meeting was attended by several of our church members, representatives from the Keweenaw Community Foundation, and volunteers, as well as board members.

Sherry Middlemis-Brown reported on how CCAM leverages the monetary donations. In each program area, she researched the value of what CCAM has distributed.

Program specific donations, monetary and in-kind, cover the bulk of program costs. Thus, while contribution from our general fund is relatively small, the impact of each program is huge. This estimate does not even consider the free store, where several

30-gallon bags of clothing and household donations arrive daily, and the same amount goes out the door with new owners. Of course, the free store and all programs are in the building with Presbytery covering most of the building mortgage. That is a huge gift!

Bobbie Dalquist reported on our financial situation, which is solid. Lois Jambekar reviewed the School Backpack program. Barb Brookhouse offered a summary of her volunteer experiences in the free store. All the reports will be available in an end-of-year report available to all stakeholders.

We have a wonderful group of volunteers, many of whom are PLUC members. Our church has an amazing mission through CCAM, our church's Helping Hands program, and the many other organizations to which our members contribute.

Helping Hands

As Sherri mentioned in her article above, PLUC is blessed by those folks who contribute to our Helping Hands program. The beginning of 2024 has been difficult for many members of the Houghton/Keweenaw County communities. As of February 28th, we have given out 6 vouchers for food and 10 vouchers for gas. This compares to 4 food vouchers and 10 gas vouchers for the same time period last year, so we have gone up just a bit (we also have one more day in February this year).

The 16 \$50.00 vouchers total a potential of \$800.00 (this entire amount might not have actually been spent as people do not always use the entire \$50.00 from their voucher). We have received \$235.00 in donation for Helping Hands for the first two months of 2024. This does not mean that we are out of funds, as we have some carry over from 2023 and we do use some vonBatchelder funds to help cover these costs. But as you

can see, your donations to Helping Hands do help a lot. Thank you for your continued support of this mission.
