### **Consistory Highlights**

# Discussion of Consent Agenda items: Treasurer Report:

1. A question was raised about why we appear to have already used half of the amount budgeted for water/sewer. Information was provided that the Treasurer had mentioned that the bill was much larger after a leak in the men's bathroom was discovered (It has been fixed.) Treasurer E. Lowther will be asked for more information.

#### **Pastor Report**

- 1. Ash Wednesday: Pastor Peter may again offer "Drive-By Ashes" in the morning. It was decided to have Ash Wednesday service in the evening. Pastor Peter will be speaking to pianist Susie Byykkonen about her availability before deciding on the time of the service.
- PLUC will again be joining with Good Shepherd Lutheran church for Lenten Evening Prayer on Wednesdays. The theme will be: Taste & See: Flavors of Christian Spirituality

3. Elder D. Sprague assisted with communion in February. Elder A. Campbell will assist in March..

#### **Furnace Problems:**

## Congregation/Corporation Meeting Highlights

Annual Report: . Sherry Middlemis-Brown stated that the Fellowship Guild report should include Jim Northey and Rob Middlemis-Brown as being involved in the work of Angel Mission. The Annual Report was approved with corrections.

**Pastor's Report:** Pastor Peter expressed his gratitude to the congregation for their support and prayers over the last year. He

also thanked Susie Byykkonen for the music she provides each week plus those who have provided special music, Office Manager Beth Smock for keeping the office running, and Fellowship Guild (the hub of the congregation) for all that they did over 2024. Pastor Peter thanked the members and friends of PLUC for all they do for Angel Mission. He asked that during the next year members and friends discuss ideas with him for the growth of our congregation and ministry.

Election of Elders: Beth Smock, member of the Nominating Committee (members include Lou Ellyn Helman and Michelle Jarvie-Eggart) informed the congregation that the committee nominates Beth Smock and Biruta Lowther as the Consistory class of 2027. There were no other nominations from the Congregation. Approved.

Election of Financial Officers: The Nominating Committee put forward Edward Lowther as the Church Treasurer and Beth Smock as the Financial Secretary. There were no other nominations from the Congregation. Approved.

2025 Budget: Rob Middlemis-Brown, Member of the Finance Committee. reviewed the 2024 budget and presented the 2025 Budget. He presented a short slide presentation showing where our income comes from and where the monies are spent. Included in this presentation was a comparison between the income/expenses in 2024 and those expected in 2025. Due to the fact that pledges were down slightly for 2025 and expenses were slightly increased, PLUC will be again operating with a deficit budget for 2025. approximately \$5,100.00. However, even though the General Funds show a deficit in 2024, the actual amount received including vonBatchelder, Helping Hands, etc resulted in a surplus of \$600.00 more received in

2024 than budgeted. The same is expected for 2025. The 2025 budget was approved.

Clerk: Clerk Terry Monson is resigning at the end of the February 2025 meeting of the Congregation/Corporation. The members and friends of PLUC thanked him for his many years of service as the Clerk. Sherry Middlemis-Brown nominated Rob Middlemis-Brown as the PLUC Clerk. The nomination was seconded by Bobbie Dalquist. Rob accepted the nomination and was approved by those attending the meeting.

**Adjournment:** Dianne Sprague moved (Mary Eckhart second) to adjourn the Meeting of the Congregation. Approved.

# Called Emergency Consistory Meeting

On Thursday, February 27, 2025, the Consistory held an emergency ZOOM meeting to discuss the need to replace the furnaces in the church. One furnace is no longer working, and the other may quite working in a matter of days. A quote had

been received from AireCare and this quote was unanimously accepted at the meeting. Pastor Peter will contact AireCare on Friday, February 28, 2025 to begin the process. It is anticipated that it will take 2 to 3 days for the need parts to be received and, once received, this should be a one day installation.

Cancelling service on Sunday, March 2, 2025 was discussed and Consistory decided to monitor the temperature in the church building. At this time, Office Manager Smock will put an article in the weekly email recommending that people dress warmly or bring a blanket. If it is decided to cancel Service, an email will be sent to the congregation.

#### The Meaning of Lent

Lent is the forty day period (we don't count Sundays—every Sunday is a little Easter!) beginning with Ash Wednesday and ending with the Saturday before Easter Sunday. Long ago, Pope Gregory I described Lent as "the spiritual tithing of the year." This is a season in which we remember Christ's forty day fast, temptation in the desert, and the forty hours he spent in the tomb before rising Easter morning.

In the preceding liturgical season, from Epiphany to Transfiguration, we were invited to contemplate the identity of Jesus as the Christ and our call to follow. The focus of Lent is on the way in which Jesus chooses to embody this identity as Christ in the world, and so we also consider the shape of our lives as we seek to embody Christ's ways. In short, Lent is about spiritual renewal in the pattern of Christ. When we incorporate aspects of the traditional Lenten practices of prayer, fasting and almsgiving, we cultivate our attentiveness to the work of God's Spirit in our lives. Such practices change us by changing our daily routines: the addition of prayer and giving or the

subtraction of fasting provide real, embodied opportunities to (re)turn to God and recenter our lives in the way of Christ.

Each Lent we get a clean start to seek the Spirit and to change our minds and our ways. From the reminder of our frailty and mortality at the outset on Ash Wednesday, throughout the 40 days, we renew our hope and place our trust in the God to whom Jesus points. And we will not be disappointed, for when the forty days come to an end, we will once again sing *Alleluia!* to the God of overflowing grace who raised Jesus from the dead and promises to incorporate us in glorious resurrection life.
