# **Consistory Highlights**

# Discussion of Consent Agenda Items: Pastor's Report:

- Elder A. Campbell assisted with communion in March and will do so again in April.
- Pastor Peter installed the new thermostat on March 18th but needs to work more on the configuration.

#### **Presbytery Meeting:**

 Elder S. Middlemis-Brown who serves as PLUC representative to the Presbytery informed the Consistory of a child protection course that Elders need to attend. Pastor Peter will check into this.

#### **Finance Committee:**

 Elder R. Middlemis-Brown asked, on behalf of the Finance Committee, how many members of the Consistory read/understand all of the information provided by the Treasurer. The Finance Committee will be looking at the report presented by the Treasurer to find ways to make them easier to read/understand.

#### **Building and Grounds:**

 While updating the wiring for the audio/visual equipment, it has been discovered that there is a gap between the roof and the ceiling. At some point, spray insulation will need to be installed.

#### **Old Business:**

#### **Furnaces:**

• The new furnaces have been installed and are working very well. They are also much quieter than the old ones. Consistory discussed how to fund the furnaces. Options included using Capital Improvement funds, Unrestricted Vanguard funds, and vonBatchelder funds. Consistory approved the use of Capital Improvement funds (with Vanguard funds used if needed).

#### **Personnel:**

 Elder A. Campbell shared the final performance evaluation tool to be used for evaluating Office Manager Smock and Pianist Byykkonen.
 Smock and Byykkonen will be given copies of the self evaluation and their job descriptions so they can complete this step of the evaluation.

#### **New Business:**

#### **Trees in the Sanctuary:**

• The trees in the sanctuary did not weather the cold well while the furnace was out. It is believed that they can be saved but need to be repotted. Elder S. Middlemis-Brown will repot them in April using vonBatchelder funds Consistory approved the use of up to \$400.00 from vonBatchelder funds for the repotting of the sanctuary trees.

#### **Consistory voting over email:**

 A question about voting over email was raised. In 2023 Consistory addressed this issue determining that voting cannot be done over email, but will be done when Consistory meets in person (ZOOM) This policy will continue.

#### **Fire Safety:**

• Elder A. Eckhart shared the results of the fire safety inspection of the church that was done by the Houghton Fire Chief on February 27, 2025. Several areas of concern were raised, including posted evacuation routes, fire extinguishers, and the lack of hard-wired fire detection devices. Cost of needed devices will be explored and Consistory (determined on results of costs) will make decisions on needed

equipment. Elder A. Eckart has already drawn up evacuation routes which will be posted. The Fire Chief will return in 90 days to review progress toward improving the church's fire safety.

#### **Audit:**

Finance Committee members B.
 Dalquist and R. Middlemis-Brown conducted an audit of the PLUC finances. There were no audit findings but a list of suggestions for improvement of accounting procedures were offered. A friendly amendment to Approve and Accept the Audit report was offered. Consistory Approved and Accepted both the Audit Committee report and the Friendly Amendment.

#### **Angel Mission**

On February 20, we held our third annual meeting of CCAM. We invited about 50 people or organizations by email and postal letter, including our major donors. Despite an RSVP request, the attendance surprised us all as we squeezed into the narrow aisle between racks of clothing and shelving units of household items. Pastor Peter and other church members involved in Angel Mission programs attended. We talked generally about our programs, passed out the Annual Report for 2024, and then toured the building. If you would like an Annual Report, there are extra copies available from Peter or I can send you a digital copy. The meeting went well and as in prior years, we had several people that were shocked by our accomplishments.

We put in 420 hours of volunteer time in February. Despite a couple of weatherrelated school closings that shuttered the store, our food pantry served 178 people, providing each with a week's worth of food per person. We are expecting that the number of people served will soon begin to increase as the federal government reduces assistance programs. Our major source of food for the food pantry is Feeding America, a program that distributes surplus food from the U.S. Department of Agriculture to food pantries at a very low cost. Without Feeding America, we are unlikely to be able to meet the local needs. We will see what happens in the next months.


